In Q2 2025, the possibilities for using Artificial Intelligence (AI) / Machine Learning (ML) and/or Smart Suggestions will be explored. Data analysis plays an important role in this. AI can analyse historical data and identify patterns. This helps to predict future working hours and reduce reliance on estimates.

Alerts for irregularities: AI can detect irregularities in time registration, such as unusually long or short working hours, and flag them in good time.

If it proves useful and practical, it will be added to PayHours 2.0 under the product name PayHours 3.0.

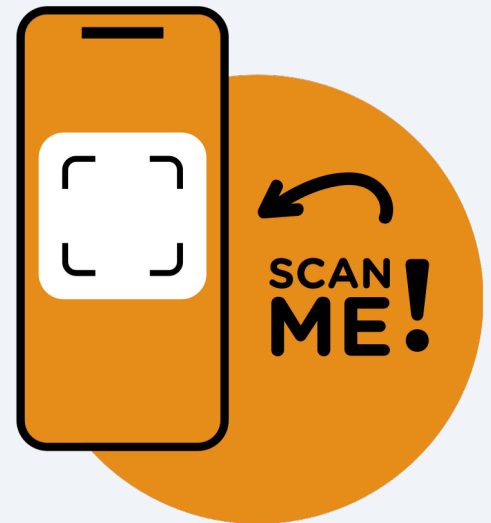

HOOR CLAS AND REGULATIONS

The following time CLAs and regulations are available:

- TLN CLA, Retail, AGF, LEO, GEO, GFG, and Belgium, Germany, the Czech Republic, Romania, England and Finland (mixed CLAs).
- We are also willing and able to add additional company-specific CLAs (mixed CLAs) and regulations.



WORK SCHEDULES AND LEAVE PLANNING

As the basis for accountable hours:

- The ability to use work schedules, including rotating (alternating) schedules in particular.
- Display of registered schedules when entering manual hours.
- And the ability to receive alerts when absences are recorded on non-rostered days.
- Use of schedules in reporting.
- Clear holiday/leave planning.



ALERTS

- Extensive options for using alerts
- Also possible for your own registered topics. This makes it possible to apply the principle of “management by exception”.
- Users can be guided through the process without having to carry out unnecessary actions or checks.
- Alerts can also highlight deviations from configured standards and unusual hours.
- There is also the option to maintain an employee file, with links to alerts generated from recorded items within that file.



SMART WORKFLOWS

- Workflow-oriented, with homepage tasks and alerts (including on your own custom fields).
- Configurable to the user's way of working and management approach, resulting in a high adoption rate.
- Ability to add shortcuts to frequently used menu items, reducing the time users spend searching.
- Within the “Trip Check” screen, there are extensive options to configure and display data — including by users themselves — providing a complete view of recorded hours and allocated allowances.



DATA COMMUNICATION

- API integrations with AFAS (both import and export).
- Cloud-native architecture.
- Synchronisation (with a user-configurable frequency) of trip data, employees, vehicles, activities and changes in workflow questionnaires.
- Mixed fleet data processing: data can be processed simultaneously from multiple onboard computer/app suppliers and/or from time registration systems.
- Hours import option (via API integration) for non-driving staff through time registration systems / booking terminals / clocking systems and/or via manual entry — all of which then runs through PayHours processing and calculations.
- Clear, structured trip data enabling fast, easy and accurate checks, with the option for manual corrections.
- Export of pay components and cost allocation to payroll and HR systems, as well as period summaries (employee portal). Also supports import and export with TMS software, e.g. for leave/sickness.
- Customer-specific integrations available, for both data import and export.





STANDARDS / BREAK SCALES / USER GROUPS & ROLES

- Support for irregularity allowances.
- Extensive options to set up standards and automatic corrections based on the duration of an activity, the location of work carried out (GPS positions), depot/base location adjustments, and/or a combination of both – including automatic and break corrections based on the related information in workflow questionnaires.
- In addition, standard actions can be automated for events such as “Start of shift” and “End of shift” (bringing forward or shifting).
- Easy-to-configure break scales.
- Option to show break corrections in period summaries for employees.
- Options to set up various “employee groups” and “roles”, with specific conditions per group. This also makes it possible to configure group/role-specific actions.
- Support for shift allowances.



OPTIONAL

- Driver/employee portal:
- Optional login for employees to exchange information via a driver/employee portal – for example, leave/absence, period summaries (raw data), documents, personnel files, expense claims, fines, vehicle maintenance, payslips, annual statements, and more.
- PayRoll NG and/or HRM NG:
- The option to manage payroll administration (payslips) via PayRoll NG and/or HR administration via HRM NG as an integrated solution within the same user environment.



USER FRIENDLY & INTEGRATIONS

Extensive options for customer-specific requirements, such as:

- Reporting.
 - Time accountability for drivers (per week / pay period).
 - Setting up various user roles (job roles).
 - Restricting access to data for users in line with privacy law requirements.
- Visually clear screens that provide a calm view – not busy or cluttered – giving users a better and faster overview of the data they are reviewing.
 - Integrated fine and damage registration (also included in exports to the payroll application).
 - Integrated report generator / analysis and dashboarding (BI).
